The objectives of the Musquodoboit Harbour and Area Chamber of Commerce and Civic Affairs are to promote and enhance the economic, social and civic well-being of the community. The MHACCCA is non-sectarian and non-partisan. As a not for profit organization, the MHACCCA is governed by a volunteer Board of Directors which is representative of the community. The board's focus is around the organization's effectiveness, and benefits to its members, and to the communities it serves.

THE MHACCCA BOARD OF DIRECTORS

We are seeking nominations of individuals to serve a 2 year term. At the end of the term, Directors may offer to serve for a second two-year term.

Board members may take on an executive role (President, Vice-President, Secretary, or Treasurer), as well as chairing or liaising with one or more committees. It would be realistic to expect to spend an average of 10 hours a month carrying out your responsibilities as a board member. All Board Members are covered by a "Non-Profit Entity Directors and Officers and Errors and Omissions Liability Coverage".

WHAT DOES AN MHACCCA BOARD MEMBER NEED TO HAVE?

Potential volunteer board members require superior vision, leadership skills, and linkages with the community and should share in the vision of the MHACCCA. They should also bring solid skill sets (e.g., communications, financial, strategic planning, etc.) to benefit the organization as a whole. Finally, they should be prepared to work collaboratively with other board members, as well as the membership, to develop the path, and the plan, to move the MHACCCA into the future.

WHAT'S IN IT FOR ME?

As a MHACCCA board member, you would have the opportunity to further hone your skills set and gain valuable governance experience. Further, the MHACCCA is at a particularly exciting point in its existence - we have been given the opportunity to help our area realize its potential. You would have a part in creating the path the organization will take into the future. In short, besides the opportunity for significant individual personal growth, you will also be instrumental in the growth of our organization and its mandate within our area.

Position Requirements for Nominees:

- Any member of the Chamber of legal voting age and in good standing shall be eligible to be elected a director of the Chamber and a director of the Chamber shall be a member.
- Time commitment: Minimum 10 hours / month including a monthly Board meetings (Includes Board preparation, meeting time and committee time)
- In-person attendance at the MHACCCA events.
- Provide on-going support by taking on various tasks and functions as required.
- Willingness to serve on at least one committee and actively participate

- Self-nominations are welcome and should include the signature of the individual plus one signature of a supporter/seconded who is a current member in good standing of the MHACCCA.
